

**PLATFORM TENNIS**  
**GLENVIEW PARK DISTRICT**  
**Special Policy and Pricing recommendations**  
(Effective July 1, 2022 through June 30, 2023)

The 39.3-acre golf course and platform tennis site is owned and operated by the Glenview Park District. The Park Board has determined it desirable at this site for golf and platform tennis programs and events to operate cooperatively with each other and to incorporate year round programming for the community and patrons at this facility.

**A. MEMBERSHIP FEES:**

An adult league play membership includes the travel league fee, a case of balls per team for league play and no court reservation fees.

**B. MEMBERSHIP**

1. **Full Adult Membership** includes 12 months unlimited access to court time when not programmed with leagues, lessons or events. This pass allows the opportunity to play on an inter-league club team. Members may make court reservations up to **6** days in advance and are limited to one court reservation per day up to a maximum of a 2 hour rental. The annual 12 month membership will begin on July 1 through June 30. This pass is available for purchase by anyone 18 years or older. Full Members will receive a 10% discount on in stock and non-sale merchandise.
2. **League Play Membership** includes all benefits of the full adult membership plus the league fee for participation in the platform tennis travel league.
3. **Junior Membership** is available for youth 17 years of age and under. They will have unlimited access to the platform courts from 3pm-6pm Monday through Friday when courts are not programmed with leagues, lessons or events. Juniors may walk on courts on the weekends all day, if available, at no additional cost. Juniors may reserve a court on the weekends at the normal court rental fee.
4. **Combination Platform and Golf Membership to Glenview Prairie Club:** a discount of 10% will be applied if both golf and paddle memberships are purchased at the same time.
5. All memberships are non-transferable and may be revoked based on manager's discretion.

**C. COURT FEES (All Full Adult Memberships Pay No Additional Fee For Courts For The Membership Year.)**

**6. Court Rates: (non-member)**

\$30/hour (non-member, resident)

\$40/hour (non-member, non-resident)

- a. Paddles and balls shall be available upon request.
- b. Hours of operation for supervised platform court usage will be no earlier than 8am and end no later than 10pm for recreational and 11pm for league play or as required by facility demand. All court lights will automatically shut off at 11pm.
- c. Hours of operation during non-prime season will be as required by program structure and court reservations.
- d. The clubhouse will be closed Thanksgiving Day and Christmas Day.

7. **Walk On Rates:** (discounted rates)

- 2pm – 6pm, Monday – Friday
- \$20/hour resident and \$30/hour non-resident
- Management has the right to adjust price and time based on demand.

**D. PLATFORM TENNIS/LESSONS PROGRAMS**

1. All fees will be established based on market demand.
2. Non-members will pay a higher fee for group and private lessons.
3. Guest pros are permitted to teach lessons only with permission from the facility management, proper insurance and certifications and payment of court fees when appropriate.

**F. NO SHOW COURT RESERVATION POLICY**

1. Members/Players need to cancel court reservations 24 hours in advance in order to avoid being charged for their court time. Warnings may be issued first, then Prairie Club staff can implement a “no show” charge for the unused court time at their discretion.
